Guidelines for Admission to Undergraduate Courses under ECA Category for the Academic Year 2020-2021

1. This year, University of Delhi conducted centralized ECA admission process 2020-21 on the basis of evaluation/markings of ECA certificates only. Due to unprecedented situation of COVID-19 pandemic and prevailing public health guidelines, trials (online/offline) were not conducted.
2. Admission to UG Courses under ECA category is available only for merit based UG courses and is not available in courses where admission is based on an entrance test.
3. The allotment of course and college to candidates under ECA shall be done in a centralized manner by the University through centralized ECA Merit List and based on preferences of courses and colleges indicated by the applicant. The allotment of College and Course will be based on the Rank of the applicant in the order of Centralized ECA Merit List and subject to availability of ECA category /sub-category in the College.
4. There will be no restriction on the number and type of course that the candidate may apply for. However, allotment of a course to the applicant will be subject to fulfillment of course-specific eligibility criteria and conform to University regulations.
5. Not more than 15% concession in academic merit vis-a-vis, Unreserved Category applicants from the last relevant cut-off may be given by a College for admission to a course subject to course-specific eligibility criteria (the list where admissions were closed for that course). The specific concession in academic merit offered to applicants by each college is listed in Table 1.
6. The seat matrix for various ECA categories and subcategories of each College is given in Table 2. Applicants are required to use this information while indicating their choice of course/college. Applicants should not opt for a college, which does not have seats for their respective ECA category/sub-category.
7. The applicants are required to refer the UG Bulletin of Information (<http://www.du.ac.in/du/uploads/COVID-19/admission.html>) for eligibility

criteria. Applicants must refer to Course specific eligibility criteria given in Sections 2.2 - 2.9 of the BOI.

8. All the declared eligible applicants for admission on the basis of ECA are required to give their preference **for all Colleges and all relevant Courses** on their Dashboard at DU UG Admission Portal based on guidelines outlined in Points #5, #6 and # 7 above. There is no limit on registering their preferences of Colleges and Courses depending on availability of respective ECA Category/ sub-category in the Colleges. All eligible applicants desirous of admission as per the Centralized ECA Merit list will be given **only one chance** to register their preferences for Colleges and relevant Courses at DU UG Admission Portal.
9. The Dashboard of eligible applicants as per Centralized ECA Merit List on the DU UG Admission Portal will be open for registering their preferences for the allotment of Course and College from Sunday, 13th December 2020 to Wednesday, 16th December 2020. All eligible applicants are informed that no further chance for registering their preferences for allotment of College and Course will be given after Wednesday, 16th December 2020.
10. The Centralized ECA Merit List of successful applicants along with the allotment of College and Course will be displayed on DU UG Admission Portal shortly. The applicants are advised to keep checking the DU UG Admission portal regularly for the admission schedule under ECA category.
11. An applicant's name appearing in the ECA Merit List does not guarantee admission in any college and course. The admission of the applicant is subject to fulfillment of course-specific eligibility criteria, the availability of course in the College and the rank in order of merit list.
12. Although the applicants have the option to choose as many college-course combinations as they wish, they are required to select only those course where they meet the specific eligibility criteria and for colleges which offer seats under their specific ECA category/sub-category.
13. All admissions under ECA Category are provisional subject to forensic examination/verification of the originals of uploaded ECA certificates. An applicant submitting false/fake certificates for seeking admission on the basis of ECA shall be

debarred from admission to any College for three years. Such admissions will be cancelled and FIR registered.
